BRACE exists to defeat dementia. We are proud of what we've achieved so far but the search for a cure remains elusive.

Dementia is such a complex condition there are still many more questions than answers.

Scientists now speak of an impending 'dementia tsunami' with a projected 1 million people in the UK being affected by 2025.

The quest for science to understand the causes, find better treatments and to seek a cure is now more urgent, more crucial than ever.

OUR HISTORY



BRACE is a pioneer in the fight against Alzheimer's disease and other dementias - it has funded ground breaking research in Bristol, the South West and South Wales since 1987 - and this dedicated research

has contributed significantly to the greater understanding of these devastating diseases.

The knowledge generated by BRACE supported dementia researchers is impressive and their work in the laboratory has directly led to ground breaking clinical trials. It's clear that long term, painstaking research is the only real hope we have to transform the outlook for those who live with and those who will live with dementia in the future.

OUR WORK



Research into unravelling the changes in brain function that lead to Alzheimer's and other dementias and how these may be prevented remains woefully underfunded. For every £10 spent on dementia health and social care in the UK, just 8 pence is spent on the research trying to defeat it.

For everyone who supports BRACE, finding a cure is something to strive for. One day our scientists could develop a life changing medication or vaccine to help everyone affected by dementia. A

Research funded by BRACE over the past decade has gathered important information relating to the actions of the blood pressure drug, losartan in the brain. This contributed to the beginnings of a £2 million drug trial, known as RADAR, to investigate the effects of losartan on the brain shrinkage and reduced memory function seen in Alzheimer's disease.

TYPES OF GIFTS

Here are four of the most common types of legacy with which you can support BRACE, or the area of our work with which you have the greatest affinity:

A Residuary Gift

This is the gift of all or part of the value of your estate after debts, other legacies and liabilities have been met. This has the advantage of automatically keeping up with inflation.

A Monetary Gift

You can choose to leave a sum of money, also known as a pecuniary gift in your Will, which you can arrange to be increased in line with inflation.

A Specific Item or Gift in Kind

This is the gift of something valuable like a property, a piece of jewellery or stocks and shares. The form of wording is the same as a pecuniary gift, except that the gift is specified instead of a cash sum.

A Reversionary Gift

This gift has the advantage of providing for your family first and then benefiting BRACE. So when the original beneficiary dies, the gift in your Will reverts to BRACE. Your solicitor or legal advisor will be able to provide you with wording for this form of legacy.
